deliberated. Motion to set the compensation for the Roadmaster, W. Danchision at \$1,625.00 monthly salary was made by R. Fellin, seconded by R. Gabardi.

Danchision at \$19,500.00 in lump sum in 2026, subject to the motion being reviewed by East Union Township Solicitor for legality, was made by R. Fellin, seconded by R. Gabardi.
